## Background

### About UKIERI

UKIERI is a multi-stakeholder partnership programme supported by the Governments of India and the UK. UK-India Education and Research Initiative (UKIERI) started in April 2006 with the aim of enhancing educational linkages between India and the UK. Since then, UKIERI has been recognised as a key multi-stakeholder programme that has strengthened the research, leadership, education and skill sector relations between the two countries. It was the first of its kind at the time in international academic collaboration and its success led to the continuation of the programme for over a decade and a half.

### About Ministry of Education

The Ministry of Education (MoE) is a ministry of the Government of India, responsible for the implementation of the National Policy on Education. The ministry is further divided into two departments: the Department of School Education and Literacy, which deals with primary, secondary and higher secondary education, adult education and literacy, and the Department of Higher Education, which deals with university-level education, technical education, scholarships, etc.

### About SPARC

Launched in 2018, the Scheme for Promotion of Academic and Research Collaboration (SPARC) is a unique initiative led by the Government of India. Keeping its promise of building a new vision and new

approach to education, the Ministry of Education has initiated the creation of a new collaboration ecosystem through SPARC. The scheme facilitates academic and research collaborations between the top Indian Institutions and the top institutions in the world from 28 selected nations, UK being one of the significant partners. Unlike any of its predecessors, the SPARC encourages long-term contributions by foreign faculty to the Indian institutions as well as supports Indian students going abroad. ## Phases of UKIERI

UKIERI Phase 1 (2006-2011) was set out to establish a framework that enabled a step change in the bilateral relationships between India and the UK on education and research.

UKIERI Phase 2 (2011-2016) focus was on leadership development, innovation partnerships, Skills development, and mobility with the aim of driving value through strategic and system-driven projects.

UKIERI Phase 3 (2016-2021) focus was on maximising impact aimed at promoting institutional and individual excellence in educational practices, research, and employability.

## UKIERI Phase 4

UKIERI Phase 4 will catalyse high-quality, international collaborative research, bringing together wide-ranging disciplines such as STEM, behavioural sciences, anthropology and social sciences to take a 360-degree approach to solving the global challenges outlined in the UK and India's strategies. The programme will respond to the demand for enhanced research and innovation in both countries by supporting the mutual exchange of knowledge and ideas at the level of policymakers and system leaders, academicians and researchers. Moreover, UKIERI 4 will contribute to building a high-quality pipeline of talented researchers in both countries by focusing on the development of early career researchers.

The primary beneficiaries of the programme will be the faculty, researchers and students in higher education and research institutions across both countries. All interventions to build capacity will be based on research that will map skills gaps and recommend evidence-based measures.

## There are three strands of UKIERI 4

- Strand 1: Enhanced UK-India research to develop sustainable solutions to global challenges, through increased institutional research and mobility partnerships
- Strand 2: Women empowerment through Leadership Development programme for women in science and research
- Strand 3: Development of research skills amongst undergraduate and post graduate students, through innovative new approaches to talent development, with a focus on inclusivity and multidisciplinary exchange.

## Strand 1: Research and Mobility Partnerships

This strand aims to foster a high-impact research ecosystem by facilitating academic and research collaborations between the UK and Indian Institutions to jointly solve problems of international relevance and develop the talent pipeline by encouraging and supporting mobility between countries of students and faculty.

### The main objectives of this strand are

- Promote and support academic and research collaboration
- Visits and long-term stay of UK and Indian faculty/researchers in Indian and UK institutions to pursue teaching and research
- Visits by Indian and UK students and early career researchers for training and experimentation in premier laboratories in the UK and India
- Joint development of niche courses, demonstrable technologies or action-oriented research outcomes and products
- Publication, dissemination and visibility through international conferences

### Call Overview

The main objective of this call under Strand 1 is to address global challenges and is aligned to the Ministry of Education, Government of India's Scheme for Promotion of Academic and Research Collaboration (SPARC). This will lead to the strengthening of academic and research links between the UK and India and It will encourage Indian and the UK Institutions to develop joint academic and research partnership that demonstrate multidisciplinary approaches to address the global challenges around climate, green development, technological transformation, and sustainable development.

The UK and the Indian institute should fulfill the SPARC eligibility criterion in addition to the UKIERI call guidelines. This strand is seeking joint research proposals in the below thematic areas

1. **Semiconductors**
2. **Artificial Intelligence**
3. **Advance Computing**
4. **Next Gen Communication**

It is expected that some of the joint ideas contribute/lead to breakthroughs in science, and/or result in sustainable technological products. Alongside research outcomes, proposals will be expected to demonstrate leadership development, both in terms of thought leadership and in the career development of team members, particularly those at the early stages of their careers. This will build the capacity of UK and Indian researchers and scientists in universities, to commercialise research ideas through deepening links and immersion in each other's innovation ecosystem.

In the application, the applicant must outline the theme, sub theme and the scope of the partnership, and the proposal should articulate a strong bilateral cooperation between the India and the UK partners. Both UK and the Indian partner should fulfil the SPARC eligibility criterion and its specific guidelines. The application should mention thinking around leverage funding and funding sources for their proposals, this should be backed by financial and implementation plan. The sustainability of the project should be thought through beyond the UKIERI and SPARC funding.

## **GUIDELINES**

The Guidelines for the Research and Mobility Partnership strand is divided in three sections. Applicants are requested to read all sections before filling the application form.

### **SECTION I: GENERAL GUIDELINES**

UKIERI Research & Mobility Partnership proposals are expected to look at one specific problem, taking a multidisciplinary approach. If the challenge is big for one university each from India and the UK to address, then consortia of universities or institutions could be brought together to ensure that there is a strong approach of combining excellence and strengths of all participating institutions.

UKIERI funding is designed to support the collaborative costs of the joint research project. It is anticipated that a considerable portion of UKIERI funds may be used to support exchanges between the research teams in the two countries. There are standard UKIERI or Ministry of Education rates for most elements that may be charged to the initiative and all applications must use these rates. Eligible costs include faculty, researchers and student exchanges with extended periods of research attachments, essential to deliver the project's proposed outcomes. It should be noted however, that in line with promoting exchange between the participating research teams, all individuals spending time in the "other" country must be part of their home research team and spend the minimum required time with that team, and no more than the maximum allowable time in the other country

### **SECTION II: SPECIFIC GUIDELINES**

A UKIERI project grants shall cover the following:

Faculty, researcher and students exchanges: it includes travel related and accommodation costs.

The proposal shall have the following essential and optional components.

#### **Essential criterion**

- Minimum two visits each by India and UK faculty totalling a combined 2 to 8 months over two years. A visit can be of duration of 15 days to 4 months. In addition to carrying out the project related research, the foreign faculty will teach one course on the topic of the proposal for 12 to 36 hours depending on the period of stay.
- A set of tangible earmarked deliverables of the collaborative efforts on the proposed topic consisting of joint research outcomes including but not limited to two or more of the following:

a) top journal publications

b) text books

c) research monographs

d) patents

e) products,

f) scaled pilots / demonstrations,

g) course materials, etc.

- Organise at least one workshop in India and one in UK on the topic of the proposal to bring together a larger community of researchers for strengthening the collaborative research component. These may be part of premier international conferences held in India as workshops or special sessions

### Optional criteria

1. Support India and UK researcher and students for long term visits of up to 89 days to the partner Institution for carrying out experiments and getting trained in an advanced laboratory facilities.
2. Support of foreign students to spend time in the Indian Institutes as part-time visiting foreign students.
3. Training of students and researchers in foreign /institutions/universities/labs.
4. Hands-on Training of students and researchers in Indian institutions/universities/labs having the requisite facilities as a preparatory course as a pathway for higher level training.

The joint proposal should be developed in two phases:

**Phase 1:** March 2024 to March 2025

**Phase 2:** March 2025 to March 2026

Each phase should have specific activities and corresponding outcomes. Phase 2 activities and outcomes should be in continuation and should add on to Phase 1 activities and outcomes. UKIERI and SPARC funding have a definite timeline for utilisation, therefore the UK HEIs should utilise all the funding by March 2025 and Indian HEIs to utilise funding by March 2026. UK HEIs are expected to provide in kind contribution by providing boarding and lodging to the visiting Indian HEIs beyond 2025 as per the phase 2 project requirements.

The UKIERI funds for up to 15% of the sum total project budget can be utilised for costs directly associated with the research activities like accessories, consumables, chemicals, video recording, field work, documentation, local travel (excluding flights), contingencies, institutional costs, miscellaneous, etc.

It is desirable to get leverage funding from external sources to amplify the project outcomes

---

No major purchase of equipment will be supported under the UKIERI funding and no scholarship / stipend to the students will be supported.

Other costs, including staff costs, directly associated with the delivery of the project and not mentioned above, will be considered on an ad hoc basis. Due approvals should be taken in advance from the UKIERI secretariat for any additional/ad hoc costs which are not part of the project proposal.

NOTE: Awardees should ensure to book economy class flights well in advance to avoid last minute price escalations. The international air-fare from, institute to institute (for example if a scholar is travelling from Manchester to Ahmedabad, the UK institution will be responsible for air fare from Manchester to Delhi to Ahmedabad and back), will be provided by economy class by the sponsoring country and hospitality will be borne by the receiving country.

UKIERI funds are not intended to contribute towards the costs of administration or other institutional overheads .

It is expected that institutions/scholars involved in the UKIERI partnership will ensure that all IPR related matters will be addressed appropriately. The IPR developed out of the projects will be decided as per norms of the participating Institutes. All disputes must have Indian jurisdiction and applicable laws of India (for any act taking place in India) to be clearly defined by the parties. The UK institute will grant the British Council an irrevocable, royalty-free, non-exclusive, worldwide right and licence to use any information, data, reports, documents, or other materials obtained, created or developed in the course of the Project for non-commercial purposes to publicise and report on the activities of the British Council in connection with the award of the Grant and the delivery of the Project. For the avoidance of doubt, such extracts would not include unpublished data where the British Council's using them could jeopardise either future publication or commercialisation by the Intellectual Property Right owner. Any special deviation must be resolved by approval of SPARC apex Committee and British Council.

Each proposal will clearly state that this proposal does not duplicate any other similar proposal funded by the Government of India which funds the same aspects of SPARC including but not limited to those partially or fully funded by Ministry of Education, DST, DBT and other Ministries of the Government of India. Complementary ongoing projects will be separately indicated.

## Section III: SPARC GUIDELINES

Both UK and the Indian partner should fulfil the SPARC eligibility criterion and its specific guidelines. Please refer to the SPARC specific eligibility criteria and guidelines in the given link [https://sparc.iitkgp.ac.in/scheme\\_details.php](https://sparc.iitkgp.ac.in/scheme_details.php)

The same joint proposal to be submitted separately by the Indian and the UK Institution through the SPARC portal and the UKIERI website respectively

### **Eligibility**

#### **For UK Institutions**

- The Lead Applicant or PI (Principal Investigator) from UK institution must be a full-time teaching faculty or full time employed in a research institution in UK.

- 
- UK Lead Applicant should be an employee of a recognised UK university (<https://www.gov.uk/check-a-university-is-officially-recognised/recognised-bodies>) or not-for-profit UK research organisations and resident within the UK. EU citizens may apply provided they hold a permanent position in a UK institution. Non-EU citizens may apply provided they hold a permanent position at a UK institution for at least three consecutive years.
  - The UK PI should not be retiring or leaving the parent institute during the proposed duration of the project
  - The applicants (both UK and India) should fulfil the SPARC eligibility criterion as per SPARC guidelines [https://sparc.iitkgp.ac.in/scheme\\_details.php](https://sparc.iitkgp.ac.in/scheme_details.php)
  - The UK applicant should submit the application form through the UKIERI website and share the relevant documents on the UKIERI mailbox.

### For Indian Institutions

- Indian lead applicant or PI (Principal Investigator) be scientists/ faculty members working in regular capacity in universities, academic institutes and national research and development laboratories/ institutes.
- The Indian PI should not be retiring or leaving the parent institute during the proposed duration of the project.
- The Indian institute should fulfil the SPARC eligibility criterion
- The Indian applicant should submit the application through the SPARC portal

### Duration and Value of Partnerships

UKIERI funds are available for partnerships up to **March 2025** however, Indian HEIs have to follow the SPARC funding guidelines. The start date for the project shall be considered from the date of signing of the contract with the UK Institute and completion date shall be considered as **20 March 2025**.

- UKIERI will provide a maximum funding of up to £ 60,000 over the duration of the project to the UK University lead applicant subject to availability of funds and up to INR 60,00,000 for the project to the Indian University lead applicant, subject to availability of funds
- Lead applicant will be expected to strictly adhere to the project timelines as there is no flexibility for extension of the project timeline.
- The UKIERI awardees are eligible to apply provided they have successfully closed the previous project (including financial closure) awarded in the past.
- Quantum of funding for the project would be decided by the UKIERI secretariat. This will be based on availability of funds, activity plan and justification submitted by the lead partner(s) of participating institutions.

### Pre-call proposal workshops & webinars

- Pre-call workshops will be delivered by the British Council team during the application phase. Interested applicants could register for the workshops once they are announced as a “UKIERI call for Pre call workshop’ on UKIERI and British Council websites.
- Information webinars would be delivered by the UKIERI team to support the participants during the application process.
- The applicants are requested to send the queries in advance at [ukieri@britishcouncil.org](mailto:ukieri@britishcouncil.org) The applicants are advised not to make frequent enquiries about the result

### Joint application form

- The project applied for, must be a joint submission by the UK and Indian teams, through their institutions.
  - The application must be submitted by the UK PI on the UKIERI website and by the Indian PI on the SPARC portal.
  - The application submitted must be endorsed by competent authorities in Lead Applicants' institutions from the UK and India.

### **Submission of application**

Application must be submitted online through [this link](#). The application needs to be submitted by the UK lead applicant through the UKIERI website and on the SPARC portal by the Indian partner. The application must be submitted online by **30 January 2024 23.55 UK time**.

The applicant shall provide all the information sought under this Call for Proposal. Applications that are received in the required format and complete in all respects shall only be shortlisted and subsequently evaluated. Please note that any application which is incomplete – including the omission of any signatures and dates shall not be shortlisted. Read guidelines in section II for filling-up the application form.

Only the application in response to this call for proposal shall be submitted. Lead applicant must submit only one application form. Lead applicant shall keep all the other team members/ partners of the project team informed about updates on the project. Any applicant, who submits or participates in more than one application, will be disqualified and will also cause the disqualification of the partnership of which it is a member.

Applications received after closing date will not be accepted.

### **Selection Process**

There would be a three-stage process for the selection of the research projects.

#### **Stage One: Initial Screening**

After the due date is over, short listing of application shall be done by UKIERI Secretariat and Ministry of Education. Under the below given conditions, the application shall be rejected:

- Application received after due date.
- Incomplete application.
- Application without endorsement from the respective institutes of India and UK.
- Application without all attachments (Annexures as per the application form including financial proposal)

#### **Stage Two: Evaluation by a panel of subject experts**

All projects shortlisted at stage one shall be assessed by sector assessment panel of Ministry of Education and UKIERI, which will include external assessors. The assessment panel will evaluate the projects as per published assessment criteria. A merit list will be prepared by the panel based on the evaluation criteria. The scores and comments received for each application will be analysed further by the project steering committee.

### Stage Three: Final Selection and approval by Project Board

An evaluation of the quality of the proposals, including the proposed budget, and of the capacity of the applicant and its partners, will be carried out in accordance with the evaluation criteria. The final decision on selection of projects for grant support shall be made by UKIERI Steering Committee comprising of members from the UK and Indian funding bodies.

#### Evaluation Criteria

Only those applicants who meet the eligibility criteria shall qualify for evaluation under this section. Applications of institutions who do not meet these criteria shall be rejected.

Proposals will be assessed based on competence and capability is proposed to be established by the following parameters

Parameter	Weightage (%)
Operational capacity and relevance (to the specified themes)	15
Proposal specific criterion (objectives with clearly defined outcomes, thematic relevance, equity and gender etc. as applicable)	45
UKIERI specific criterion (sustainability, mutuality and complementarity of both India and UK)	20
Budget and cost effectiveness	20

#### Signing of Grant Agreements

British Council will sign the contract with the UK institutions for the selected project proposals.

Sanction letters would be issued by IIT Kharagpur (SPARC National Coordinator) for Indian institutions for the selected project proposals after the submission of requisite documents by project investigators.

#### Disbursal of Grants

- The UK institutions will receive the grant after signing of the contract, through British Council. The grant will be disbursed in two instalments, by February/ March 2024 and July/August 2024. British Council will disburse 60% in first instalment and the remaining 40% of the grant in second and the final instalment
- Indian institutions will receive grant from IIT Kharagpur (SPARC National Coordinator) after completion of required documentation.

#### Monitoring & Evaluation

- Each project will be jointly monitored by the UKIERI Secretariat and Ministry of Education
- The Lead Applicants shall submit bi-annual progress reports during the project period. Any discrepancy in the use of Grant or any other issue related to the project shall be communicated to UKIERI Secretariat and at the earliest.

- Joint report by the UK HEI should be submitted every 6 months to the UKIERI Secretariat clearly indicating the achievements made within 6 months of the report period against the indicators mentioned in the work plan.
- Joint report by the Indian HEI should be submitted every 3 months to Ministry of Education through the SPARC portal clearly indicating the achievements made within 3 months of the report period against the indicators mentioned in the work plan. At the end of the project, a closure report is to be submitted to Ministry of Education through the SPARC portal
- At the end of the project duration as per the grant agreement, a closure report is to be submitted by the UK HEI to the UKIERI Secretariat.
- UKIERI Secretariat and Ministry of Education have the right to withdraw the project if project implementation varies widely in relation to the proposal submitted against the call for proposal.

### **Gender Equality Statement**

The forms and annexures shall be duly filled to avoid any ambiguity.

**A user will have to create an account on the online tool and then fill and submit the application form.**

### **Project Work Plan**

Project Work Plan should be filled in detail with activities demarcated for each month separately along with its outcome and indicators. No modification shall be entertained after submission of the application form.

### **Financial Proposal**

- Please summarise the estimated costs (£ Sterling) over the period of the project monthly. Please assume the start date for project as **15 March 2024**.
- Most reasonably priced economy class travel and accommodation should normally be booked for all travel. The scholars will abide by the national policy of the respective government about travel.
- Project specific institutional costs - up to 15% of the total project funding: Funds can be used to contribute for such needs. However, funds cannot be employed to meet the regular administrative costs or running costs of the institution.
- Any other costs to be met from UKIERI funds should be itemised.
- The following costs are not eligible under UKIERI:
  - debts and provisions for losses or debts
  - interest owed
  - items already financed in another framework
  - currency exchange losses
  - direct costs of staff time
  - administration or other overheads

Please use pounds sterling (GBP or £) as the unit of currency throughout the financial proposal, even though some costs will be incurred in (INR) Indian rupees for UK participants. Similarly, Indian participants use INR as the unit of currency in their proposal for the funds required from Ministry of Education. Please double check all amounts and calculations in this section, as it is an important part of the scoring of the proposal, and changes cannot be made after submission, nor will the UKIERI team or assessors check or recalculate on your behalf.
